- Online voting begins July 20, 2018.
- Your ballot must be RECEIVED no later than 11:59 pm EDT September 11, 2018.

Voting by Mail

- Mark the appropriate box next to your choice(s) like this . Do not sign or write comments on the ballot.
- When you have finished marking the ballot, separate the bottom stub along the dotted line.
- Place the marked ballot in the solid envelope marked "SECRET BALLOT ENVELOPE."
- Sign the separated stub where indicated certifying that you are authorized to cast votes on behalf of your organization.
- Place the signed stub and the "SECRET BALLOT ENVELOPE" into the double window envelope so that the post office address and bar code are visible through the windows.
- Seal and mail the envelope (no postage necessary if mailed in the United States).
- BALLOTS MUST BE RECEIVED BY September 11, 2018: LATE BALLOTS WILL NOT BE COUNTED!
